



TERMS AND CONDITIONS

- 1** The promoter is the English Heritage Trust of the Engine House, Fire Fly Avenue, Swindon, SN2 2EH ('English Heritage').
- 2** These terms and conditions apply to the Dance for VE Day Competition' (the 'Competition'), running from February 12 2020] until 17.00 on 8TH March 2020 (the 'Closing Date').
- 3** The Competition is open to residents of the United Kingdom aged 18 years or over except employees of English Heritage and their close relatives and anyone otherwise connected with the organisation or judging of the Competition.
- 4** There is no entry fee and no purchase necessary to enter this Competition.
- 5** By entering this Competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
- 6** To enter the Competition entrants must complete and submit the on-line application form before the Closing Date. After this date no further Competition entries will be accepted.
- 7** Entries submitted in any other way, including by hard copy, will not be accepted.
- 8** Obscene or inappropriate entries will not be accepted and English Heritage reserves the right to reject any entries for any reason at its sole discretion.
- 9** Each entrant warrants to English Heritage that his/her entry is for English Heritage to support a cost free to attend event or activity that commemorates the 75th anniversary of VE Day and that the said event or activity in their application will take place.
- 10** Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.
- 11** English Heritage bears no responsibility for entries not received for whatever reason.
- 12** English Heritage is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this Competition.
- 13** The Competition Prize (limited to one per county) in England only is:
 - 13.1 An hour and half (1.5) swing dance experience: two swing dance instructors, 2 x 20 minute taster classes, a social dance demonstration and DJ-ed musical interludes at a local VE Day street party, or
 - 13.2 An hour and half (1.5) inclusive dance workshop (for community venues, care homes etc.): two swing dance instructors, 1 to 2 inclusive dance classes delivered by trained inclusive dance practitioners, a social dance demonstration and DJ-ed musical interludes, or
 - 13.3 An enhanced hour and half (1.5) swing dance experience and performance: incorporating swing dance performers, 2 x 20 minute taster classes, the possibility of a live jazz combo, a performance and DJ-ed musical interludes (as required) at a local VE Day street party.
- 14** The Competition Prize will be one of 13.1/13.2/13.3 chosen and allocated by English Heritage as they deem appropriate to the winning entries.
- 15** The Competition Prize is as stated and no cash or other alternatives will be offered. The Competition Prize is not transferable.
- 16** The Competition Winners will be chosen by a panel of judges appointed by English Heritage.



- 17** Each Competition Winner will be notified by email within 14 days of the closing date. If a winner cannot be contacted or does not claim their prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
- 18** Each Competition Winner shall be responsible for all the arrangements related to their own community celebration including but not limited to: event coordination, standard health and safety, plans for inclement weather, risk registers etc. Upon notification, more detailed event information will be requested from Competition Winners by the Dance for VE Day team.
- 19** Should a Competition Winner need to cancel the VE Day street party or activity stated within their Competition submission, or should the type of event or number of people attending differ from that stated in the same the Competition Winner must notify English Heritage at least 7 days before the agreed VE Day street party /activity date.
- 20** English Heritage's decision in respect of all matters to do with the Competition is final and no correspondence will be entered into.
- 21** Television and print media will be invited to capture the VE Day street party and the Competition Winner agrees and shall ensure his/her/their partner agrees to the use of their names and images in any publicity material, as well as in their submitted entry. Any personal data relating to the Competition Winner and his/her/their partner winner or any other entrants will be used solely in accordance with current UK data protection legislation and will not be disclosed to a third party without either person's prior consent.
- 22** All personal data provided to English Heritage will be held and processed in accordance with the requirements of the Data Protection Act 2018 and the English Heritage Privacy Policy found at: www.english-heritage.org.uk/about-us/our-people/our-policies/. We will keep your personal data safe and secure. We will not share it with other organisations without your knowledge and consent, unless required by law to do so.
- 23** Information collected to fulfil administration of the Competition and events will be deleted no longer than 30 days after use is no longer required by English Heritage.
- 24** English Heritage reserves the right to withhold or cancel the Competition prize in the event of non-compliance with these terms and conditions. English Heritage further reserves the right in its discretion to amend the Competition terms and conditions at any time. Any changes shall be effective immediately upon posting to this webpage.
- 25** English Heritage reserves the right to cancel this Competition at any stage, if deemed necessary in its opinion, or if circumstances arise outside of its control.
- 26** The rules of this Competition shall be governed by and construed in accordance with the laws of England and Wales and the courts of England shall have exclusive jurisdiction in relation to any disputes arising out of these terms and conditions.
